Aluminium Roller Shutters are a commercial / industrial roller door product, manufactured from individual extruded aluminium slats.

- Flush mounted locking with various keying options available.
- Operate manually by spring balance or with motorised system
- UV resistant acrylic panels at 300mm centres
- Acrylic panels can be omitted if ventilation is required.

A wide range of sizing is available for the Aluminium Roller Shutters.

Solid / clear vision option

• Up to a maximum width of 5.75 metres and maximum height of 5 metres.

Series 3 option

• Up to a maximum width of 8 metres and maximum height of 6 metres.

Aluminium Roller Shutters can be supplied in a clear anodised or powder-coated finish. Aluminium Roller Shutters are not fire rated.

SCOPE OF USE

Aluminium Roller Shutters are suitable for internal or external use in commercial and industrial buildings such as shop fronts, storage facilities and counter tops.

Aluminium Roller Shutters cannot be insulated.

Aluminium Roller Shutter Series 3 are not weathertight and are not available with windows.

The clear vision and vented options can be used to provide natural light in areas where natural light is required.

The Series 3 shutter can be engineered to suit a wind zone in accordance with AS/NZS 1170.2.2021 and NZS 3604.

CONDITIONS OF USE

Aluminium Roller Shutters must be installed by a competent and experienced commercial door installer, as per the installation instructions.

Operating instructions must be followed for correct use.

Openings must be designed with minimum requirements given in the technical drawings.

These doors cannot be used where fire ratings are required.

All Aluminium Roller Shutters have a durability of at least 15 years under normal use and correct maintenance conditions.

Hazardous Building Materials

Ventilation

The Vented option allows up to 49% air flow to pass in and out of the vented slats.

Natural Light

The Clear Vision and Vented options could allow natural light to filter into a building.
