Clearspan Roller Shutters are a commercial roller door product, manufactured from UV Resistant polycarbonate slats, joined by extruded aluminium rails, and fitted with nylon end locks to prevent lateral movement and to assist with operation.

- Flush mounted locking with various keying options available.
- Operate manually by spring balance or with motorised system
- Fixed and removable mullion options available.
- Low side room option for tight installations.

A wide range of sizing is available. See Security Grille and Shutter Selection Chart for maximum sizing.

Clearspan Roller Shutters can be supplied in a clear anodised or powder-coated finish.

Clearspan Roller Shutters are not fire rated.

Operating instructions must be followed for correct use.

Openings must be designed with minimum requirements given in the technical drawings.

These doors cannot be used where fire ratings are required.
