### DESCRIPTION

The Liteslider Industrial Sliding Door is a commercial / industrial sliding door product, tailor-made and manufactured to suit the size of the opening, chosen cladding and wind loading requirements. Galvanised steel frame construction for a top hung door or galvanised purlins or RHS frame construction to suit a floor track option.

A wide range of sizing is available, top hung option up to a maximum width of 5 metres and maximum height of 5 metres, or a floor track option up to a maximum width of 20 metres and maximum height of 8 metres.

A wide range of cladding options to suit your requirements from aluminium glazing, colour steel or aluminium-profiled cladding to polycarbonate translucent cladding, or mesh infill panels.

These doors can be operated manually or with a motorised system.

The Liteslider is not fire rated.

## SCOPE OF USE

The Liteslider is suitable for internal or external use in commercial and industrial buildings to provide vehicle or pedestrian access, and to secure storage facilities such as plant and machinery rooms, or factories etc.

Litesliders are not typically used to provide ventilation though they can provide up to 50% ventilation dependent on chosen cladding.

These doors can be used to provide up to 50% natural light in areas where natural light is required dependent on chosen cladding.

These doors can be engineered to suit a wind zone in accordance with NZS 3604.

The Liteslider cannot be insulated.

## CONDITIONS OF USE

Litesliders must be installed by a competent and experienced commercial door installer, as per the installation instructions.

Operating instructions must be followed for correct use.

Openings must be designed with minimum requirements given in the technical drawings.

These doors cannot be used where fire ratings are required.

### Structure

Liteslider Industrial Sliding Doors have a durability of at least 15 years under normal use and correct maintenance conditions.

### Ventilation

Dependent on cladding. It can provide up to 50% ventilation

### Natural Light

Dependent on cladding. Can provide up to 50% natural light.
